As mentioned in the last newsletter, the Class of 1950 Reunion Committee felt that we should funnel any moneys raised for our high school through an existing organization known as the THS Badger Foundation (a tax-exempt entity which administers funds for the good of Tucson High School and its students.) If you want to contribute funds to benefit Tucson High School, send the Class of 1950 Reunion Committee your check **made payable to the THS Badger Foundation**. We will keep records and then forward the funds to the Foundation.

For those of you who pledged a total of \$100 by the year 2000, now is time for the payment of \$25 for 1998 payment. We, of course, will accept donations in any amount for the Foundation.

TUCSON HIGH BADGER FOUNDATION

The Tucson High Badger Foundation held its annual breakfast and meeting in October 1997. At that time four new members were inducted into the Hall of Fame (no members of the Class of 1950), and six girls and boys from Tucson High were each given \$100 grants from the foundation. The goals of the Foundation are to perpetuate the traditions and history of Tucson High School, to promote the educational and cultural activities of the students and alumni, and to encourage and support its students to graduate.

Dues to the Foundation are \$10 a year and paid by members on the one-year anniversary of their payment. Lifetime membership dues were to go into an endowment fund to produce income to pay the grants that are given to needy students to fill various needs. The foundation has not received enough money to do this at this time. Grants are therefore paid from annual income. It is the plan of Foundation Board of Directors to seek donations for an endowment fund, not necessarily donations for lifetime memberships.

Nominations for the Hall of Fame must be received by April 1, 1998. The nominations must be presented at a May screeening meeting, the date to be announced later. The nominations may be presented by a member of the Board. You may contact Suzanne Laws Bernard (520-747-8212), who is currently serving a three-year term on the Badger Foundation Board, for details on presenting a nomination.
